# A naturalist's view of La Foret

THE Trinidad and Tobago Field Naturalist's Club journeyed to La Foret in north-east Trinidad last November. Located due south of Galera Point, the rocky coastline may not be very attractive to sea bathers, but the area offers scenic views and a chance to explore the shoreline environment.

Along the shoreline you can find plants like the seaside grape (*Coccoloba uvifera*) which is easily identified by its broad oval leaves. A few trees were in fruit and the grape-like clusters make identification even easier (the ripe fruit are edible). Also growing along the shoreline (and also edible) was the fat pork (*Chrysobalanus icaco*). This shrub produces a large globular fruit, the skin of which is generally pink. The pulp is soft, white and mildly sweet.

The crashing waves have eroded the rocks along the beach, creating some fasci-

nating formations including small sea arches and shallow caves.

Despite the natural beauty of La Foret, there were many signs of human visitation.
